MODERATOR'S REPORT

The elders are grateful for the amazing team of pastors, staff, and volunteers under Mark's leadership that enable us to be a church that aims to help people become deeply rooted followers of Jesus. As elders, we regularly interact with Mark and the Senior Leadership Team, and our confidence in the team is unwavering. Northview is currently experiencing a positive season.



Northview's pastors, elders, and their families had our annual retreat at Rockridge Canyon in early May this year. It was a great chance to build team and community, worship together, and also think about what the next ministry year should look like. We discussed topics such as a team SWOT analysis (strengths, weaknesses, opportunities, and threats) and explored ways to maintain elder renewal while preserving institutional memory and culture. Our plan includes implementing term limits of three terms, each lasting three years.

We eagerly anticipate the start of construction for our new building in September. Extensive work has gone into updating and refining the building design to align with Northview's current and long-term needs. The Development Committee has played a crucial role in this process, and we're also strategically considering growth in Mission and our future Chilliwack plant. Additionally, we're forming a new society to facilitate legacy gifts and better manage the church's real estate.

As you will read in the Stewardship Committee report on page 26, we are blessed to finish this fiscal year with an anticipated giving number of \$9.5M. For F2024/25, we are recommending a giving budget of \$10.25 million along with an expenditure budget of the same magnitude. As well, giving and pledges for



the building campaign remain strong. Take time to read the Stewardship report as it describes updates to the inflationary and design worship centre building costs that are being worked through.

Today marks the end of terms for three elders who have made such big contributions to Northview's leadership over the years. Phil Routly has been an elder for 13 years and most recently led our Governance Committee. You will have read his monthly reports from the CoE. Phil will continue in various committee and commission roles. Sean Allison was only an elder for three years but made an outsized impact with his focus on missions and leadership of our Discernment Committee. He will be missed as he leaves to focus more on Wycliffe translation work. Lastly, Marvin Klassen wraps up his second tour of duty as a Northview elder. Through these many years of leadership, Marv has played an important role, most recently leading our Governance Committee. We continue to pray for Marv and his family as they walk the challenging path of his cancer diagnosis. Under Jeff Gamache's leadership, the Discernment Committee is actively identifying elder candidates for affirmation in November

Let us continue to pray for Northview and seek God's will for his church.

LEAD PASTOR REPORT

Every year when it comes time for our end-of-the-ministry year reports I find my heart drawn to Psalm 103.

Bless the LORD, O my soul, and all that is within me, bless his holy name! Bless the LORD, O my soul, and forget not all his benefits, who forgives all your iniquity, who heals all your diseases, who redeems your life from the pit, who crowns you with steadfast love and mercy, who satisfies you with good so that your youth is renewed like the eagle's. - Psalm 103-1-5

As a church family we have indeed been deeply and richly blessed by the LORD!

The ministry reports included in this book will encourage you as you reflect on the work of the Holy Spirit among us; from our youngest to our oldest, every area of ministry has experienced growth this past year. Overall attendance has increased by 15%! We have been given so many incredible resources and opportunities for ministry.



Weekends

As I look back on this year of ministry, my primary area of public ministry is the interaction I get to have with people at our weekend services. I am so encouraged by the hunger for God's Word that is



clearly seen in our church family, as people are listening and wrestling with how God's Word challenges, grows, and strengthens us. Our vision to see "deeply-rooted" followers of Jesus is fanned into flame by the regular rhythms of gathering "under" the Word of God on the weekends. I love the conversations I get to have at every site or service I visit - what a great church family!

Preaching

We spent the summer of 2023 in the book of Colossians, being encouraged by the theme verse: Colossians 1:28 *Him (Jesus) we proclaim, warning everyone and teaching everyone with all wisdom, that we may present everyone mature in Christ.* Through the fall and winter, we finished our deep dive into the Gospel of John. This was a unique study in that we focussed for several months on the final 7 days of Jesus' earthly life. It was a deep and rich study! Finally, in late spring we turned to the theme of "renewal/revival" and took a page of Old Testament history as our anchor point; calling it simply REBUILD. What I've been encouraged by in this OT study is how relevant the Word of God remains for our day!

Vision & Growth

Behind the scenes, the on-going conversations with our pastors and elders about the future of the church continues to inspire me! Our vision to train leaders and plant churches in our needy nation is daunting, but also encouraging. As we prepare for a new building at Downes Road, we are always looking for ways to accommodate growth in numbers, while we wait. This year we opened a 4th weekend service at Downes on Saturday night and saw great growth in the number of people who were giving up their "prime seats" on Sunday morning to make room for newcomers. Even with over 1000 attending many Saturdays, our Sunday mornings remained full for which we praise God.

Baptisms & New Members

A personal highlight for me is listening to the testimonies of the individuals being baptized in our services. God is continuing to draw people to Himself in significant life-changing ways and this is so encouraging to us all.

Leadership Issues

I continue to thank God for the solid group of godly men He has given to lead us on our Council of Elders. These men give many hours of their time, their attention, and their prayers to the work of God here at Northview. As we look to the future, I'm grateful that God has given us a strong culture of leadership as a church family. Having seen the crisis that can happen when a church does not have a sound leadership structure, I have deeply appreciated the men who serve us as Elders. I invite you to join me in praying for them and their families.

Additionally, God has given us an incredible team of pastors and staff who are gifted and called to the various areas of ministry they are working in. It is always encouraging to watch people serving in their "sweet spot" and seeing the joy that God gives in ministry. There are of course challenges and obstacles that arise in every organization, but our team has been amazingly flexible and joyful as we navigate the opportunities of ministry.



Our team values (if you don't know) are:

Win as a Team (An all-hands-on-deck approach to collaboration)

Double the Master's Money (Talents are to be invested! Hard work matters!)

Humble Positive Attitudes (We take God seriously - and ourselves humbly)

Dreams

As we head toward summer and then into another fall of ministry, we are re-aligning our ministry teams for more effective long-range ministry. We have grouped our pastors into 4 working groups who will give collaborative vision for each area of ministry. One unified goal that we are tackling together, is the goal of reaching 20% children in our weekend services. The reason for this is that young families are the future - and we want to strategically reach the 1,000's of children in our city who are currently far from God.

Finally, I can't close this report without saying a huge thank you from Karolyn and myself. When we came to Northview 5 years ago to lead the church planting vision, we did not anticipate the role God would call us into, and we are so grateful for the many words of encouragement we regularly receive. The most encouraging word we hear is "We are praying for you!" - and we know that many of you are regularly, and earnestly praying for God's good work among us. Thank You so much!

MULTIPLICATION REPORT

New Opportunities

- Chilliwack Plant See attached document below.
- Our daughter church, Tricity Church, is in the planning stages of planting a church in Maple Ridge. At their congregational meeting at the beginning of May, the membership affirmed their elders' recommendation to move forward with the plant. Northview will partner with Tri-City in the following ways:
 - We have sent a gift of CAD \$100,000 to Tri-City as our partnership contribution toward the plant. (The funds will come from the unspent Multiplication budget).
 - Pastor Ezra Okoti will sit on the Maple Ridge Church Plant task force.
 - We will encourage members of our Mission Campus congregation who live in or near Maple Ridge to prayerfully consider joining the new Maple Ridge plant.
- We are moving forward with the following partnerships:
 - Chris Pignaitello planting in Edmonton
 - Wesley Hynd planting in Calgary
 - o Colton Carrick planting in Charlottetown, PEI
 - o Clay Bitner Moving this summer from Warman, SK to plant in Edmonton, AB.

Funding Model

1. Partner Agency Support

- a. Partner agencies/ministries we are supporting
 - i. Mile One Mission NFLD
 - ii. C2C Collective & City to City Canada Church Planting Agencies
 - iii. Multiply Punjabi and First Nations Ministries
 - iv. Mission Hill Church Calgary (MB) Church planting catalyst support
- b. Northview's relationships with supported planters and Partner Agencies will undergo annual evaluations based on their effectiveness and alignment with Northview's ministry objectives.

2. Church Planter Support

- a. The total allocated funds for Church Planter support amount to \$250K per year.
- b. The formula for church planter support will be structured around a three-year declining investment, outlined as follows:
 - i. For MB partners, the support is set at \$75k over three years; (\$36K/\$24K/\$12K + \$3K resourcing)
 - ii. For Non-MB partners, the support is set at \$45k over three years; (\$24K/\$12K/\$6K + \$3K resourcing)
- c. Funding priority will be given to MB partners.
- d. The availability of funds within the funding model will be a key factor considered during the planter support approval process.
- e. This model would enable us to provide ongoing support for between 9 and 12 planters.
- f. One-time gifts for start up expenses considered on case by case basis
- g. Capital requests will be considered on a case-by-case basis
- h. Current examples of partner church planting support (Currently @ \$70K)
 - i. Harrison replant support going to Central Chilliwack (MB)
 - ii. Surrey site of Christ City Church (MB)
 - iii. Southeast City Church Plant Ottawa (MB)
 - iv. Past support: Creekside Church (Dawson Creek)
 - v. One-time gifts: Redemption Church (PEI), Meadows Church (Langley)

3. Northview Internal Church Planting Initiatives

- a. Northview plants will be entirely funded by Northview, utilizing a combination of funds from the staff compensation budget and the multiplication fund.
- b. Initiatives that we consider being Northview "direct" planting
 - i. Support to Praxis Church
 - ii. Support of future plants like Chilliwack and Maple Ridge
 - iii. Hosting of Church Planters Retreat and Preaching Conference



Church Planters Retreat

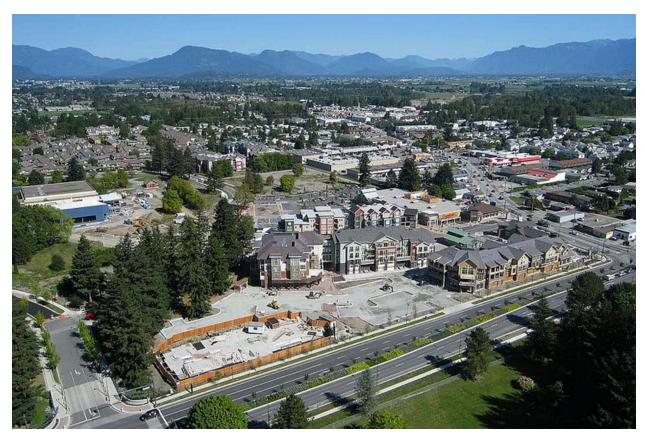

NORTHVIEW COMMUNITY CHURCH CHILLIWACK CAMPUS

SPRING 2024



Introduction

In recent months, we have discussed the potential of establishing a new Northview Campus in Chilliwack, specifically in the Vedder, Garrison, Tzeachten neighborhood. Our objective is to create a vibrant gospel outpost in the south end community of Chilliwack that's committed to reaching the lost and making deeply rooted disciples of Jesus.

Need and Opportunity

The City of Chilliwack has been developing a 2040 Neighborhood Plan which forecasts the population of the Sardis-Vedder neighborhood to reach 50,000 by 2040. This plan delineates the city's strategies for residential and commercial development, which is currently taking place in the south end of Chilliwack.



The data below outlines the spiritual need in Chilliwack;

- The estimated population of Chilliwack currently stands at approximately 114,000.
 Chilliwack's population is projected to continue growing, with a population increase of between 2.0% per year (2035) and then 1.5% per year (2040).
- As of 2022, Canada's six most non-religious census metropolitan areas are all in British Columbia. Chilliwack ranked 5th in the country with 49.4% of its population identifying as non-religious.
- Approximately 45.5% of the population in Chilliwack (52000 people) identify as Christian, but only 10-15% of the population (11000-17000 people) attend a weekend gathering. (*That's a generous estimate*)
 - o Currently, Chilliwack has approximately 62 churches.
 - It is estimated that half a dozen of these churches have an average weekly attendance of 1000 people.
 - Despite having approximately 62 churches in the community, as of 2021/2022,
 Chilliwack ranked 5th on the list of metro area residents with no religious affiliation in the country.
- Most of the churches in Chilliwack are located north of the freeway. New communities in Sardis, Garrison, Vedder, Ryder Lake, and Promontory have limited to no churches. Therefore, a possible location for a Chilliwack plant would be south of the freeway.

Strategic Partnership

The BCMB Conference Minister, Rob Theissen, has shown strong support for Northview's plan to establish a campus in Chilliwack. He acknowledges the necessity for a gospel presence in the rapidly growing southern community of Chilliwack and has offered his assistance in garnering support from other MB Churches in the area. Additionally, he is willing to provide input during the planning and establishment phases of the campus.

Both the leadership teams of Central Community Church and Main Street Church have embraced Northview's desire to reach the residents of the Vedder/Garrison neighborhood. They have expressed interest in collaborating to establish a gospel outpost in the southern part of Chilliwack. Potential areas of collaboration include:

- Making announcements in their respective gatherings about the establishment of a sister church in the southern part of the city with the aim of reaching the lost.
- Identifying individuals from their congregations who may join Northview's staff team to serve in Chilliwack.
- Recognizing that some of their committed members residing in the Vedder/Garrison community may choose to join the new campus with the objective of reaching their neighborhood.

Formal collaboration with these partners will commence once the COE (Council of Elders) approves the proposal.



Timeline

To date:

- We have strong buy-in from members and attendees who reside in Chilliwack and participated in our interest meeting in January.
- The BCMB Conference (Rob Thiessen) has extended their support and offered assistance in the planning and establishment of the campus.
- Two well established MB Churches in Chilliwack have expressed a desire to work with us in establishing the campus.
- Council of Elders approved the decision to proceed.

What's yet to be done:

- Discern/hire potential planter if the proposal is approved, we hope to hire a planter by July 01 2024.
- Pre-Launch Gatherings September 2024 to Spring 2025
- Soft Launch late spring/summer 2024
- Launch of Chilliwack Campus Fall 2025

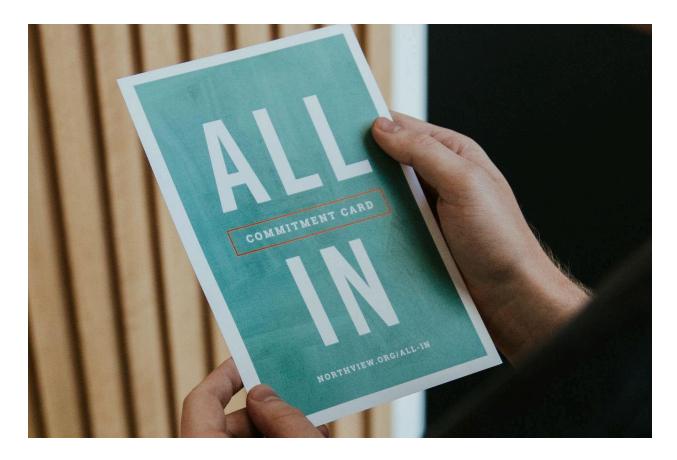

DEVELOPMENT COMMITTEE REPORT

Downes Road Project

This June will be a significant milestone as we move forward with the final iteration of drawings for the new sanctuary facility here at Downes Road. From our perspective, the long process and delays have proven beneficial to the refining of the facility design. These last few months have been focused on some small but important updates to the new sanctuary building drawings. The design team has worked tirelessly on all levels and spaces to ensure that the functionality of the building will be well-suited and will meet the needs for the home campus ministry for many years to come.

While the drawings for the building have not yet been submitted for a building permit application as of this meeting, we hope this will take place in the next few weeks. In order to move forward with site preparation, the civil portion of the project has been separated from the main project and has been or is due to be submitted as a separate permit application by the end of June. The civil portion is largely the same as the previous design which was approved in the previous building permit application several years ago. The project team has been in conversation with the city regarding this process and are expecting a relatively quick turn on this permit. This will move the start of the project forward while the review of the overall building permit application is being completed. The Building Permit will be submitted once feedback from all consultants has been received. Final budget numbers will be available following the consultants submission. There have been increases due to labour and material costs as well as recent alteration and significant improvements.

Mission Campus

In the spring of 2023, we commissioned a strategic planning commission to look at the future of the Mission Campus. The goal of the commission was to consider what the next 2, 5, and 10 years could look like and how Northview could best plan for the inevitable growth in the campus. While the scope of the plan considered ministry, leadership, training, and discipleship needs, the development committee has been focused on the building and facility needs.

The team in Mission is making great use of the current facility, and it is clear that there is work to be done to improve functionality and prepare for future growth. The Development Committee has completed a feasibility study of the site and is reviewing renovation and expansion options. Improvements would likely be completed utilizing a phased approach to address the immediate, short term, and long term needs. We can expect to see more of the details of the plans over the next year.

Chilliwack Campus

With the planned launch of a new campus in Chilliwack, the Development Committee is in search of suitable space for long term lease/purchase in the Sardis/Garrison district.

Cyrus Centre

The Cyrus Center continues to serve the needs of our community for at-risk youth. As the challenges and population in this community increases, so does the need for more space. Over the last 12 months there have been opportunities to review several local sites that could prove to be very suitable for this ministry. As of this date, no properties have been secured but stay tuned. Opportunities to support growth and expansion for this ministry may come soon.

DISCERNMENT COMMITTEE REPORT

The Discernment Committee has three tasks: (1) the re-discernment of current elders, (2) the discernment of possible elders, and (3) the discernment of possible members for elder led committees of the church: Development Committee, Discernment Committee, Governance Committee, Personnel Committee and Stewardship Committee.

This spring, the Committee worked through the process of re-discerning two elders: Darryl Kropp and Bruce Belsher. The Committee made the recommendation to the Council of Elders (CoE) that these elders be put forward at the June Congregational meeting for a vote to continue as elders for another three-year term.

During the spring, the Committee also gathered input regarding several elder candidates, and as mentioned in the Moderator's Report, the CoE is planning to bring three elder candidates to the congregation for affirmation at the November AGM.

GOVERNANCE COMMITTEE REPORT

The Governance Committee is not the flashy, showy, thrilling group you might expect it to be. We don't build buildings or raise enormous amounts of donations.

We build and maintain the foundation of all that we do, by ensuring that we have the right policies and procedures in place throughout Northview, so that the church we build will endure. Any changes to our policies and procedures must be approved by the Council of Elders.

I've had the privilege of serving with the committee members for only a couple of years. This past year, following the leadership of Marv Klassen, who served in this capacity for many, many years, I moved into the chair. It is Marv's kind of institutional memory and heart to preserve the core of who we are as a church that helps make Northview the strong, growing, thriving church that it is. I salute him for his years of dedicated commitment and service.

Every year, we review our Constitution, By-Laws, Operating Guidelines and other policies of Northview. This results in a combination of updating, revising, clarifying and implementing all those aspects which focus on lowering our potential risk for issues that could damage the church and its reputation.

Over the last year, we've focused on a number of issues that will have a deep impact in the future.

This can include such questions as:

- What are the advantages and disadvantages of having elders serve for multiple 3-year terms? What do we gain with a maximum of three terms before taking a break, and what do we lose? We concluded that the best option is three terms, and that's something that will be phased in.
- Is there a better structure for receiving and investing legacy gifts and real property, which Northview will control, while maintaining as low a risk as reasonable? As a result, we are in the process of establishing a separate society for that purpose, which will have the Council of Elders as the official board. This discussion also included a review of our investment policy.
- What is the best way to support the ministry of local organizations and individuals who are involved with our community in ways that Northview is not? In conjunction with the SLT (Senior Leadership Team), we now have policies for Local Outreach Workers, as well as a Formal Partnership Policy.
- How do we best care for and lead campuses and church plants which are not under our direct influence? What are our responsibilities for various levels of responsibility? For example, how are the relationships different when we serve Mission (with its own facilities), East and Central Abbotsford (which rely on Downes Road to provide ministry the other 6 days a week), and Praxis in Kelowna (for which we are legally responsible until they become an independent church)? What about a Chilliwack Campus? North Peace Church in Fort St. John? How about other church plants we support with training and/or funding?

Sometimes, the questions we ask are more philosophical:



- What is the shepherding role of the elders, in relation to what our pastors and staff do every day? How can we together better care for our flock?
- What is our appropriate role for Northview members who have moved out of the areas, but for whatever reason, wish to continue as members?

And occasionally we discuss more mundane but important issues, such as the level of expenditure each staff member can approve.

As a committee, we are thankful for the support and encouragement of the Senior Leadership Team and in fact all of our pastors, who contribute in so many ways to the health of Northview, and to the opportunities we have in the future.

PERSONNEL COMMITTEE REPORT

The work of the Personnel Committee has focused on two main areas: Compensation Analysis and Lead Pastor Review. The Northview staff/pastor compensation review happens at least every three years to ensure we are up to date. The Lead Pastor Review happens every year to give Pastor Mark feedback from the elders and his direct reports.

Compensation Review

The compensation review used a variety of tools to assess where we stand on this important topic. We accessed survey data from across Canada and the United States, comparing Northview's grid to that of other similar sized churches. Then we gathered more specific data around churches in our particular housing/cost of living market. We also gathered data from other sectors of the local economy (Abbotsford School District and City of Abbotsford employees). Finally, we used the average cpi index for Canada, BC, and Vancouver to help us account for cost of living increases/decreases. With all of this data in mind we then went to our grid and adjusted it as necessary.

Lead Pastor Review

Each year the Personnel Committee leads the review of the Lead Pastor. This process includes meetings with Mark, assessment of his yearly goals and a survey of his direct reports and the elders. The results are then shared with Mark to both encourage him with what he has done well and then shed light on ways for Mark to continue to grow in his effectiveness as the Lead Pastor.

I would like to thank the members of our Personnel Committee who contribute keen insight and expertise.

STEWARDSHIP COMMITTEE REPORT

This report reviews the April financial results (giving and expenses for 10 months of 2023/24), review of the April 30, 2024 Balance Sheet, review of the giving and targets achieved to April 30 regarding the Downes Road building project, a comment on the current and expected estimate for the building project, and the proposed 2024/25 budget of which there is a motion to consider to approve or not. At the meeting it is expected that the May financial results may be available and will then be reported on.

1. April (10 months) Financial Results

At the end of April 2024 giving reached \$7.98 million, just under 80% of the annual budget and \$186,000 (2.4%) more than last year at this time. Expenses reached \$7.54 million, \$455,000 more than last year. This created a surplus of \$434,000 before interest income of \$795,000 and expenditures related to Internally Restricted Net Assets.

While year over year increases in giving are encouraging, if one adds the building project giving for the current year, the year over year increase jumps to 27.3% with \$2.27 million provided in contributions to the building project.

The Internally Restricted Expenditure of \$70,000 was related to a contribution to Mile One Mission in Newfoundland for assistance in acquisition of a building and architectural drawings. Although shown below the expenditure line on our internal statements this expenditure will be shown with all other expenditures but will reduce the Internally Restricted Assets accordingly.

There should be no concern regarding higher expenses than last year (\$455,000) as last year there was considerable lag in expenditures in 2022/23 as we "shook off" the effects of Covid.

Expense variances to date include:

- Care lower expenses than budget primarily due to low travel costs and minimal contracts for service incurred.
- Children's lower expenses than budget due to Day Camp Summer 2023 operations showing a surplus of \$17,000 when a loss of \$8,000 was budgeted.
- Food Services due to higher costs of food and the tremendous success of the Saturday night meal service at Downes and Central.
- Church Planting lower than budgeted expense due to holding off on grants and assistance to church planting as year-end numbers firm up.



It is very encouraging that Praxis giving is up 6% over last year at \$617,000 and more than 14% if NVCC assistance in 2022/23 is excluded. Expenditures are higher than budget and revenue by almost \$18,000 due to leasehold improvements and equipment purchases related to the new leased premises at Rotary Centre for the Arts in Kelowna and office and mid-week space. They expect to be balanced by year-end but any shortfall will be picked up by Northview. However, since the inception of Praxis Church, they have run surpluses so this is not a concern.

Projections for Year End (June 30. 2024)

It is expected that giving will reach about \$9.5 million unless we receive some unexpected contributions. Expenses are expected to reach upwards of \$9.5 million reflecting balanced operations for 2023/24. Further giving beyond \$9.5 million will enhance our ability to provide church planting assistance beyond what we intend at this time.

Balance Sheet as of April 30, 2024

A guick review of the balance sheet reveals the follow:

Assets:

- a. Current Assets, primarily made up of Short Term Investments, are driving the increase of almost \$3.6 million.
- b. The mortgage balance provided to TriCity Church of \$1.3 million at June 30, 2023 has been reduced by principal payments by the TriCity church of \$23,000 in addition to the interest payments calculated at 5% up to April 1, 2024 and 5.5% since then..
- c. Fixed Assets have decreased overall due to the increases to the Accumulated Depreciation on our Buildings and Equipment but is offset partially by an increase of \$279,000 in the Building Project. This increase to \$820,000, reflects the planning costs incurred to April and will form part of the total costs of the Project.

Liabilities:

- a. Current Liabilities are up by \$2.1 million primarily due to contributions to the Building. These contributions are not recognized as revenue until the building is complete and we start amortizing the asset and related contributions.
- Deferred Contributions is made up of earlier donations used for earlier Building projects.
 Its reduction of \$90,000 is matched against amortization taken on those items for the 10 months ending April 30, 2024.

2. Building Project Giving Update

At the end of April 2024, 81% of the targeted \$30 million had been realized in cash contributions and pledges totaling \$24.2 million. And this is before any work has started apart from removing the bubble. There is much to be thankful to our Lord.

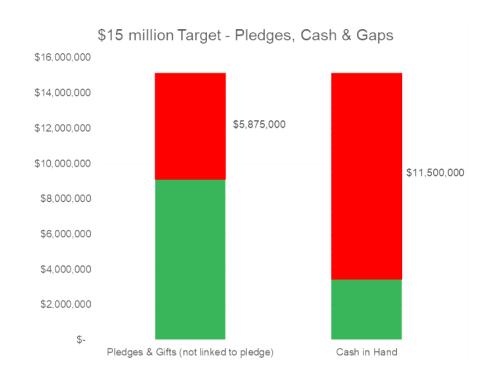
When we provided the update at the April 2023 Special General Meeting to approve the Building project, the amount realized was \$15.1 million or 50% of the target. Since that time pledges of \$8.5 million have been received and cash received in addition to those pledges of \$650,000.

To date we have had a \$34% conversion rate from the pledges made which suggests that folks are able to honor their commitments, which for most are multi-year commitments. This is very encouraging indeed.

Below is a graph showing the sub target, rounded to \$15 million, with red signifying the amount of pledges that are still required to achieve the \$30 million target which is \$5.9 million. The amount of cash still needed to reach that target is \$11.5 million.





Building Target History

The \$30 million target was developed from estimates provided to Northview in 2019. Those estimates included a \$25 million building target, \$2 million in contingency funding and \$3 million for renovations of the existing facilities. Since that time there has been almost 4 years of construction inflation. There have also been dramatic improvements in design that includes a new placement of the building in relation to the existing facility, increased seating with better sight lines, and an increased basement for sound equipment along with maintenance shop/storage (30% increase in square footage).

Once we have submitted final drawings for building permits, those drawings will go out to consultants. When the consultants give us their quotes, we'll have a much more accurate estimate on the price. The timeline for that should be around August. We are confident that the \$27 million construction estimate we had before has increased significantly. Just reviewing the Stats Canada March 2019 to March 2024 "All Items" indexes, the general inflation rate is 18%. Construction inflation is undoubtedly more than that 18% number. This means the \$27 million value will be well over the \$30 million target without any value associated with renovations to the existing facilities.

While there could be concern that the new building estimate will reflect project creep, it has to be remembered that this project will stand for another 50 or more years if the blessing of the Lord over the past 40 years is any indication.

Once the new estimate is available, it will be communicated widely.

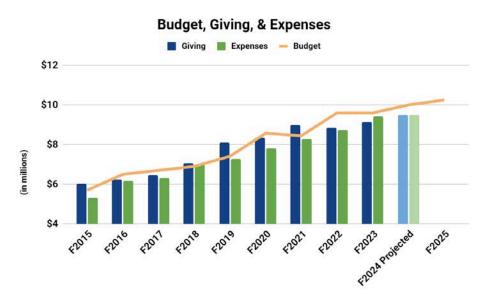

3. Budget 2024/25

The Stewardship Committee and the COE are recommending a giving budget of \$10.25 million along with an expenditure budget of the same magnitude meaning a balanced budget is proposed. The overarching budget is similar to the previous year.

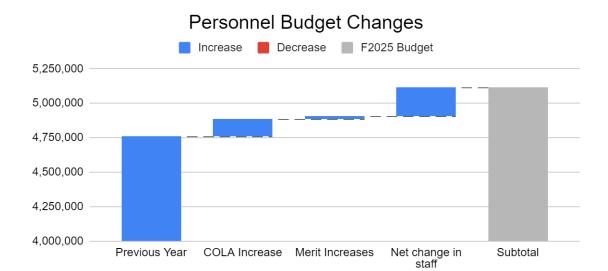


Here are the items of note that have changed.

The most significant change is that the compensation budget has increased and is now at 49% of the giving budget. In 2023/24 it was at 48%. Even at just under 50%, we are still at the bottom of the range of Personnel budgets as a total of total giving when compared to other churches. With cost of living, much more normative is between 55-60% of total budgets going to Personnel costs. We will be hard pressed to keep the Personnel budget at 50% and we may not want to live with the consequences of such levels in the future.

This increase in funding for cost of living lifts will be at 2.82% which is the average of the Stats Can CPIs for Canada, BC, and Vancouver as of March 2024. It also allows us to build out the pastoral staff, add Childrens ministry staffing needs, and add part time roles in various other ministry locations.





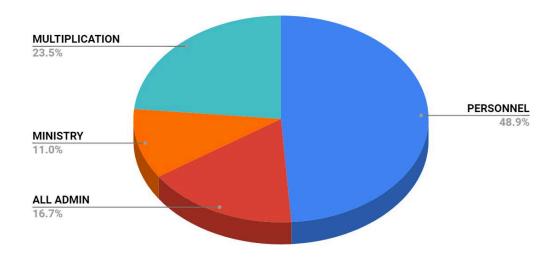
The MEI allocation for 2024/25 is \$40,000 less than the 2023/24 allocation. MEI has been made aware of this change. We still significantly support MEI as a ministry partner, but this allows us to move funds to other lines. The \$40,000 will be divided between an increase to the BC Conference, who is struggling financially, and to keep our Church Planting budget at a minimum of \$700,000.

Administration costs are up primarily because we under budgeted for insurance costs last year and are facing an additional increase this year.

Leadership Development costs are lower primarily as we have one less student being onboarded than we have graduating.

Children's ministry is going up for a few reasons. We are growing the ministry as we had 14% more kids at our Abbotsford campuses from the previous year - the budget needs to grow accordingly. We are also not getting the large allotment of grants for Canada Summer Jobs that we normally receive. The cost for the Day Camp staff will hit the Children's Ministry budget line resulting in the overall cost for Day Camp being quite a bit higher than normal.





While Praxis Church Kelowna is separate from our Northview Budget, it is important to know that their revenues and expenses will form part of our financial statements. For the upcoming ministry year they are proposing a balanced budget based on a giving target of \$900,000. Praxis has roughly \$400,000 in cash from pre-launch fundraising and previous year surpluses, which would cover any sort of shortfall, but it is hoped that balance will be saved for the future to form part of a down payment for a site of their own.

THEOLOGY COMMITTEE REPORT

The main focus of the Theology Committee this past year has been on Northview's teaching posture regarding questions of sexual orientation and, to a lesser extent, gender identity. Northview continues to align with the historic teaching of the Christian church in terms of human sexuality and sexual ethics, and more pointedly as that doctrine is expressed in the Mennonite Brethren Confession of Faith. Northview, as a congregation within the denomination, takes a particular approach to issues like this, so the work of the Theology Committee also encompasses looking closely at Northview's distinctive approach to this important issue.

Throughout the autumn and winter this past year, the Theology Committee was focussed on a review of Preston Sprinkle's Grace and Truth course as it was taught in Northview's TLC sessions over the past three years. Most of the pastors and elders went through the course in weekly study sessions in order to thoroughly examine the material as it had been presented to congregants. The Theology Committee presented their report to the elders, which concluded that while the course teaching was doctrinally sound, some of the material in the books and videos rested on convictions about human nature and identity that the Theology Committee felt it could not completely endorse. [In particular, Sprinkle's apparent acceptance of the concept of "sexual orientation" as a neutral state—neither inherently sinful, nor perfectly legitimate—was found to be problematic.]

The Theology Committee has recommended that in future, any courses on this topic should make use of a range of materials (books, videos, etc.) in order to allow for more precise teaching and to avoid aligning ourselves exclusively with just one of them or with one specific curriculum, giving the perception that Northview is endorsing any one author's materials. We know that the topic of human sexuality is rapidly changing, and we wish to reserve the right to add and/or change resources as they are developed and become available.

In recent months, the Theology Committee has also been overseeing the development of an internal-use position paper on this topic, including a lengthy FAQ section, meant as a guide for Northview pastors and lay leaders as they lead community groups and other ministries.

PRAXIS CHURCH REPORT

As we move toward the third anniversary of Praxis this September, the signs of grace continue to abound throughout this ministry. We moved into our new Sunday home in the Rotary Center for the Arts and are on a trajectory towards three gatherings beginning this fall. This new venue has provided more seats but it has also opened opportunities to reach many more with the gospel. Every week we are seeing many new people come and check Praxis out, and nearly every week we are seeing new people come to faith. While we Baptized 50 over our first two years of ministry, we have already Baptized 26 this year, and have new people signed up to be Baptized next month already.



Outside of Sunday we've seen encouraging growth as well. Our Community Group ministry has grown significantly over the past year, with 16 groups that meet during the week. Our Jr. Youth and Youth groups that meet throughout the week, and our monthly kids events have also seen rapid growth..

Our office and midweek space where our staff has been a great asset to the ministry as well, providing a place for our mid-week ministry rhythms to take place. We ran a marriage Alpha (which was completely full), and saw many miraculous stories take place within several marriages. We've also used the space for leader training, women's groups, and several other opportunities that weren't available during our first few years of ministry without having any mid-week space.





God's Spirit is moving in mighty ways and every week we are seeing more and more people show up hungry to hear the Bible taught. Thanks for your prayer and support this past year! We desire to see the gospel proclaimed to 1000's of more people and a vibrant gospel proclaiming church within reach of everyone in the Okanagan Valley, and **we'd love it if you would join in praying with us for:**

- 1. **More opportunities to share the Gospel.** 42% of Kelowna reports having no religious affiliation (2x the national average), and the student population is set to almost double in the coming years as UBC expands. Pray for opportunities to reach 100's more with the Gospel.
- 2. **More Church Planters!** There are many cities in need of church revitalization and many municipalities with no gospel presence at all. Pray that God would begin to call and burden more people to the Okanagan to be a part of this gospel movement throughout the Okanagan Valley.

DISCIPLESHIP REPORT

The past year we've seen 1078 people in Men's and Women's Bible Studies, 884 engaged in Community Groups, and 519 in Theology, Life, and Culture Courses. Participation doesn't always translate to life change, but does position people to mature in their relationship with Jesus. We see evidence of this through the markers of "new life" in people. We've seen 121 people baptized, and a significant number of people with an exciting openness to explore Christianity (for either the first time, or because they are returning to faith). The Holy Spirit is drawing people who are far from God! Another blessing is seeing people step into new levels of serving (i.e., hosting Community Groups, facilitating conversations in our studies, and teaching large groups from a stage).



One specific highlight for Community Groups were our special "Group Boost" events that had 237 people representing 28 Community Groups dive into equipping about how the church can practically fight against the epidemic of isolation and loneliness.

And, finally, this past spring saw the return of our Women's Retreat! 275 women spent the weekend at Rockridge Canyon in worship and prayer, learning from panel discussions and teaching on developing "Gritty Faith".

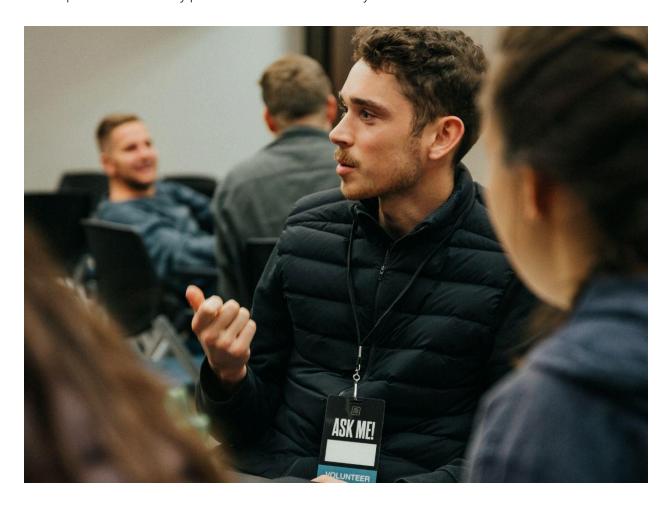
